The Possibilities Created Because of One Woman's Passion

**What in the World ...
are we doing?
... because of one woman's passion?**

Clementine Msengi came to the United States in 1995 from Rwanda following the 1994 genocide, when both of her parents along with 800,000 Rwandans, were killed. Although she spoke three languages when she arrived in Cedar Falls, she had to learn to speak English before she could continue her education. She soon enrolled at UNI where she received both her undergraduate and Masters Degrees.

Through a grant from the Echoing Green Fellowship that she received in 2003, she launched her Bright Move Network to help immigrants and refugees like herself to become a part of the community. She has given credit to AAUW member Stacy Van Gorp, project director for "Opportunity Works", for helping her to prepare for the rigorous interview process in New York. Because of the success of her program she has been awarded many more grants to help her expand the program and has received national recognition by being given the "Outstanding Citizen by Choice Award" in April of this year. Clementine's remarkable story, featured on "Living in Iowa" on PBS, will be shown at the November general meeting.


Driving directions (15 minutes from Cedar Falls):

Go 2.8 miles (past the American Martyrs Retreat House, the entrance to Beaver Hills and across two bridges) and watch for the green and white sign pointing to New Hartford. Turn left (west) onto C67/Beaver Valley Road. Drive 5.7 miles and watch for a cemetery on the left and a barn on the right. Turn right immediately before the barn, onto Deer Trail Drive. The house is white and limestone. If you went too far and are at the stop sign, turn right, then turn right again and enter Deer Trail Drive from the opposite end. AAUW Legal Advocacy Fund Celebrates its 25th Anniversary

The AAUW Legal Advocacy Fund is thrilled to celebrate its 25th anniversary this year. In the late 1970s a group of women professors and coaches at Cornell University became fed up with the sex discrimination they were facing at the university. AAUW's Ithaca, New York, Branch rallied around the women, providing them with financial and emotional support as five Cornell employees began a lawsuit against the university: Zahorik v. Cornell University. The branch sought fund raising assistance from the national AAUW organization. As a result, in the summer of 1981, the AAUW board of directors voted to establish the AAUW Legal Advocacy Fund (LAF).

LAF has been very active over the past 25 years. It has supported more than 100 cases and our plaintiffs have expanded to encompass all women on university campuses who experience sex discrimination be they faculty, staff, or students. Additionally, LAF has proactively fought discrimination by engaging in campus outreach and public education efforts, as well as awarding excellent programs (the Progress in Equity Award) and people (the Speaking Out for Justice Award) for efforts to improve women's experiences in higher education.

AAUW members are rightfully proud of LAF's accomplishments, but so much work remains to be done. LAF fields calls and e-mails almost daily from individuals seeking attorney referrals or asking how to proceed after encountering sex discrimination. The need for LAF's services remains vital, and the program's impact is clear. Just consider this comment from LAF plaintiff Lynn de-Martin:

"My case settled the day I learned I received an LAF award. During the negotiation, the university acknowledged wrong doing, but stated they did not believe I had the tenacity or the finances to pursue them in court..I was then able to state that I was prepared financially because I had received an AAUW LAF award. The U.S. District Court Judge was very impressed and told the [university] to get their calculators out. Finally I had their attention."
