## Why Vote NO?

Commonsense gun laws are supported by a strong majority of Iowans. According to Iowans for Responsible Gun Laws,

- 91% support banning carrying a firearm while under the influence of drugs or alcohol
- 85% support prohibiting felons from possessing firearms
- 85% support requiring background checks on all gun purchases
- 83% support requiring gun safety courses before purchase of a handgun.

Sadly, instead of ensuring that Iowa's gun laws reflect Iowans' intentions, in 2021, the Iowa legislature repealed laws requiring a background check to purchase a gun and requiring a permit to carry loaded, concealed handguns.

On the November 8 ballot will be a constitutional amendment proposed by the lowa Legislature to make ownership and use of guns a "fundamental right," making good gun laws nearly impossible to enact. Whether they own weapons or not, lowans of both major parties and especially those in law enforcement warn against adopting this constitutional amendment.

Because our AAUW public policy advocates for "freedom from violence and fear of

violence, including gun violence and hate crimes, in homes, schools, the workplace, and communities," AAUW of Iowa and the board of this Cedar Falls-Waterloo Branch advise to Vote NO on the proposed amendment.

The Iowa Firearms Coalition says vote yes. In opposition are AAUW of Iowa and 31 other organizations, many of them faith groups, because it goes far beyond the Second Amendment.



Among editorials all over Iowa in opposition, the Des Moines Register editorial board wrote, "There is no justification for undertaking a 'strict scrutiny' experiment here in Iowa. The case against this amendment stands even if it were not going before Iowa voters in the same year as gunmen slaughtered 19 children and two teachers at an elementary school in Uvalde, Texas; two young women in a church parking lot in Ames; or three campers, including a child, at Maguoketa Caves State Park. Amending the Iowa Constitution . . . isn't easy because the implications can be profound and difficult to reverse. . . . Changes to the Iowa Constitution should be careful. This idea is haphazard and harmful. Iowans should flip over their ballots and vote no."
